

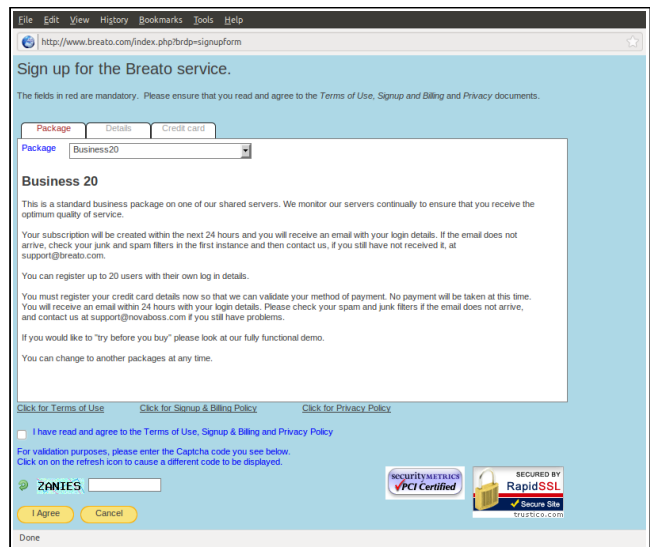
## The Trial System

Breato provide a free trial account so that you can build a sample application to understand how Breato works and what it can offer you and your organisation. When registering for the trial, we will only ask for your name, email address and organisation name. There is no obligation to use Breato after the trial period. The trial account will be deleted seven days after being created for you.

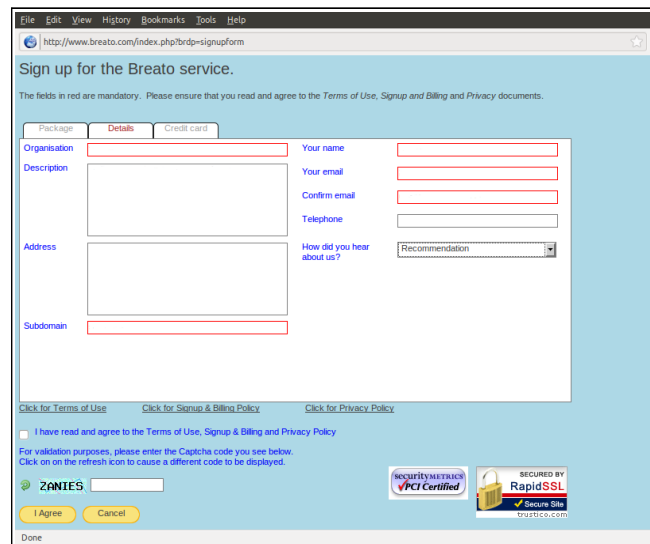
## Signing Up with Breato

Go to the Sign Up page on the Breato web site where you can read the Terms of Use document, our Privacy Policy and the Pricing Information for Breato service.

If you want to sign up, click on the “Subscribe to Breato” link and the “Sign up for the Breato service” form will be displayed. This form allows you to select the package you want to subscribe to.




Once a package has been selected, enter the registration details for the first user of the system, who will be the initial Account Administrator. Complete the mandatory information, denoted by the fields with red borders, and as much of the other information as possible.



Finally, register the details of the credit or debit card that will be used to pay for the Breato service. The card details will be processed by CreditCall, our payment service provider, who will verify the card details. The initial payment will be for the first month of the service, after which Breato will generate a new bill on the month anniversary of the registration date thereafter.

Please read the policy documents, then click the check-box to confirm that you understand and accept the Terms and Conditions for the service. Now enter the CAPTCHA code and press the "I Agree" button to confirm you want to sign up to the Breato service.

The credit card details will be shown again so you can confirm they are accurate, after which they will be submitted to our payment service provider for authorisation.

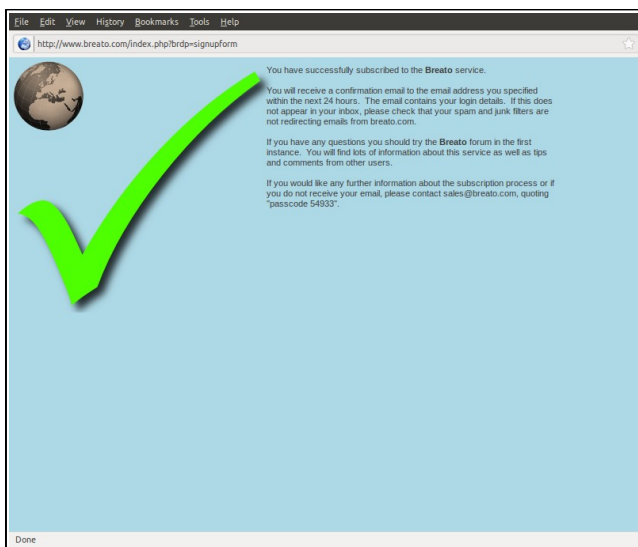

Once the credit card authorisation is complete, a confirmation page will be displayed showing the Pass Code that uniquely identifies the Breato account that has just been created. Please use this Pass Code on all correspondence with Breato.

You will also receive an e-mail confirming the transaction along with a PDF of the invoice from Breato for the first month's service.

Once the account has been created, you will receive another email which contains the login details. This step can take up to 1 hour to be completed.



## Cancelling your Subscription

You can cancel your subscription to Breato at any time using the **Unsubscribe option on the Subscription menu**. Enter your email address, contact telephone number and a brief description of why you want to unsubscribe. Any feedback you can give on the overall system and the applications would be greatly appreciated. As a security precaution, one of our representatives will be in touch within 1 working day to confirm your intentions and to describe how you will get your data. After unsubscribing, your data will be erased from our system.
